Sir,

In continuation to this office letter of even number dated 14-01-2021, this is to inform you that pursuant to the relaxation granted by NCTE till December-2022 and on recommendations of the Committee constituted for the purpose, the Vice Chancellor in anticipation of approval of competent bodies has been pleased to authorise grant of temporary affiliation for running M.Ed programme at your college with an intake capacity of 40 seats subject to the fulfilment of following conditions:-

- ✓ grant of temporary affiliation will be reviewed at the time of next admission;
- ✓ that surprise visits shall be made by the university authorities to ascertain overall functioning, development of required infrastructure etc.;
- ✓ the temporary affiliation shall be suspended/withdrawn in case the institution does not follow the norms and conditions fixed by the University;
- ✓ that faculty appointed/engaged be paid as per UGC norms;
- ✓ that separate infrastructure be made available for M.Ed course;
- ✓ that the college shall engage supporting staff for the purpose as per requirement;
- ✓ the selection for remaining faculty positions shall be made by the proper Selection Committee of the University before starting M.Ed programme;
- ✓ the fee structure shall be same as prescribed by the State Govt. for the programme/course;
- ✓ the institution shall complete the deficiencies, what so ever, during the relaxation period (i.e December 2022) granted by NCTE; and
- ✓ the college shall deposit the required affiliation fee with university.
